Rental Policies

If you have any questions about these policies please call us.

You must be 21 years of age to Rent from Extreme Adventure Rentals LLC. A contract and liability waiver (rental agreement) is required for all rentals. You are responsible for anything that happens to yourself or the machines, or anyone else who rides the machine while under contract. You must present a Valid D.L. and Credit Card for the rental agreement.

Machines are supplied fully fueled, cleaned, serviced and oiled. The renter is solely responsible for returning the machines cleaned and fully fueled with premium unleaded fuel (\$10 will be charged per machine for cleaning / Refueling Charges -- \$15 minimum or 1.5 times current local fuel rate). If you rent a machine for more than one day, you are responsible for checking oil levels daily and maintaining appropriate oil levels.

You are obligated to abide Utah state OHV Laws

- www.stateparks.utah.gov/ohv/default.htm - please stay on the trails.

You may allow younger riders to ride machines you rent under contract, provided they have either a valid D.L. or State OHV Certification #. The renter assumes all risk liability for machines and riders.

Trailers require a 2-inch ball and flat light hook-up. Out-of-town delivery available. Machines can be dropped off and/or picked up from your site for an additional charge of \$1 per mile, based on availability.

Security Deposit - a \$250 security deposit will be charged for each rental agreement.

Rental Day:

Full Day = 8a to 5p

Half Day = 8a to 12p or 1p to 5p

Late Return Fee:

You will be assessed a \$40 per hour fee for late returns!

Insurance:

Damage/Collision insurance is not available at this time, Renter is responsible for all risk and damage.

Physical Limitations:

Riding an ATV, as a general rule can be more challenging than driving a car because it requires coordinated physical input such as leaning and moving on the seat to assist the ATV in turning. Please understand your own personal limitations and ride wisely. Please note that the maximum amount of weight an ATV can accommodate is a total of 350 pounds.

Reservations:

Reservations are recommended and can be made with a 25% booking deposit. Walk-ins welcome (based on availability). Full payment is due upon departure.

**Holidays and Holiday Weekends - Memorial Day, 4th of July, Labor Day - require full payment two (2) weeks prior to departure.

Preference may be given to multi-day, multi-machines renters.

Pricing does not include tax or gratuity or optional accessories, unless otherwise stated.

Rates do not include transportation or delivery, unless otherwise stated. Transportation, lodging and meals, and/or delivery can be arranged on a fee based basis.

Payments may be made using Cash, Personal or Company Checks, American Express, Visa, Master Card and / or Discover.

All prices are subject to change without prior notice and are only honored when there is a written, signed agreement. (2007)

Cancellations:

All rides go rain or shine. EAR, at it's sole discretion, may reschedule trips based on extreme, dangerous weather.

No discounts or refunds will be granted for late pick-up or early return.

Trip Dates That Don't Include Holidays

Trips may be cancelled two weeks prior to departure, with notice, for a booking refund or apply to another rental date.

 Canceled within two weeks - booking deposit may only be used to reschedule another rental date.

 Canceled within 1 week - forfeit booking deposit.

 Canceled within 72 hours (3 days) - you will be charged 50% of rental rate for machines requested.

 Canceled within 24 hours (1 day) - you will be charged 75% of rental rate for machines requested.

 Canceled day of or no show - you will be charged 100% of rental rate for machines requested.

Trip Dates That Include Holidays

You will be charged the full rental rate for machines requested two weeks prior to departure.

Cancellation within two weeks - 100% loss of full payment. In the event we are able to re-rent your reserved machines, a refund may be given commensurate with regained lost funds from subsequent rentals.
